



2025 Estimated Year-End Distributions

The Vest S&P 500® Dividend Aristocrats Target Income Fund, Vest US Large Cap 10% Buffer Strategies Fund, Vest US Large Cap 20% Buffer Strategies Fund, and Vest Bitcoin Strategy Managed Volatility Fund (each a “Fund” and collectively the “Vest Funds”) are declaring year-end income and/or capital gain distributions on December 29, 2025. Dividends from net investment income, if any, are declared and paid monthly for the Vest S&P 500® Dividend Aristocrats Target Income Fund, annually for the Vest US Large Cap 10% Buffer Strategies Fund and the Vest US Large Cap 20% Buffer Strategies Fund, and quarterly for the Vest Bitcoin Strategy Managed Volatility Fund.

Record Date – The date on which you must be a shareholder of the Fund in order to be eligible for a distribution.

Distribution Date – Also known as the ex-date, the date on which the Fund’s net asset value per share will reflect the payment of distributions to shareholders. If you have selected reinvestment, the distributions will be reinvested as additional shares into the fund at the day’s closing price.

Reinvestment Date – If you have selected reinvestment, the distributions will be reinvested as additional shares into the fund at the day’s closing price.

Payment Date – If you have not selected reinvestment, the distributions will be paid on this date.
